## CONSENT TO NATUROPATHIC MEDICINE

Welcome to Intuition Wellness Center, PLLC. This document contains important information about our professional services and policies and will represent an agreement between you and Intuition Wellness Center, PLLC. The term "patient" represents children, adolescents, adults, couples, or families who are the identified patients receiving services at Intuition Wellness Center. "You" refers to "patient" or, if the patient is a minor, may also refer to a quardian.

#### **NATUROPATHIC MEDICINE**

Naturopathic medicine is the treatment and prevention of diseases using natural means whenever possible. Naturopathic physicians assess the whole person and generally use gentle, non-invasive techniques such as diet and nutritional supplements, botanical medicine, homeopathy, hydrotherapy, physical medicine, lifestyle counseling, and, in some cases, pharmaceutical medicines.

Treatment at Intuition Wellness Center, PLLC, often calls for an active effort on the patient's part. You have the right to participate in treatment decisions. You also have the right to refuse any recommended actions or withdraw informed consent to treatment. Your provider will advise of the consequences of such refusal or withdrawal.

## RISKS & BENEFITS \_\_\_\_(initial)

Even the gentlest therapies can have complications in combination with certain physiological conditions or in those with multiple medications. It is very important that you inform your naturopathic physician immediately of any disease process that you are experiencing, if you are on medication or over-

the-counter drugs, or if you are pregnant or breastfeeding. Risks may include: aggravation of pre-existing symptoms; allergic reactions to supplements or herbs; pain, bruising or injury from venipuncture; or side effects associated with pharmaceutical medicines. Your naturopathic physician strives to anticipate and to explain all potential risks and complications.

On the other hand, naturopathic medicine has been shown to have many benefits for many people. Your doctor will support you in using natural means to stimulate your body's inherent healing capacity. You may experience a boost in both emotional and physical wellbeing. There are no guarantees that you, or your child, will experience these benefits and/or risks.

### **FEES AND PAYMENTS** (initial)

Intuition Wellness Center, PLLC fees vary by service. The fee schedule is available online at intuitionwellness.com or you can request one. All patients are responsible for payment at the time the appointment is held. Naturopathic services are not billed directly to insurance by Intuition Wellness at this time. You may be able to receive some reimbursement by your health insurance company by directly submitting a superbill to them, which Intuition Wellness can provide you at your request.

Lab costs, prescribed medications, and supplements are not included in the cost of the office visit. There may be additional fees associated with report writing, telephone conversations, attendance at meetings with other professionals you have authorized, preparation of records, and the time spent performing any other service agreed upon. Intuition Wellness requires you place a credit card on file to charge phone consultations/call

backs or authorized case management services at the time of service. If patients become involved in legal proceedings that require a team member from Intuition Wellness Center to participate, you will be expected to pay even if the team member is called to testify by another party.

In circumstances of unusual financial hardship, you may inquire about fee adjustment options. If your account has not been paid, Intuition Wellness Center, PLLC may suspend services until a financial arrangement is agreed upon.

You will be charged your full fee for appointments missed or cancelled without 24-hour notice unless cancellation was due to circumstances beyond your control. You will also be responsible for the full fee for the appointment even if tardy and missed time cannot be made up.

### **CONTACTING YOUR PHYSICIAN** \_\_\_\_(initial)

Many team members at Intuition Wellness Center, PLLC are engaged in the world around them in a variety of capacities. Thus, most do not maintain 9a.m. - 6p.m. office hours and, when in the office, may be attending to other clients or related matters. Your naturopathic physician may often not be immediately available. If you are experiencing an emergency, call 9-1-1 or go immediately to your nearest emergency room. If your naturopathic physician will be unavailable for an extended period of time or if you need to be seen sooner than scheduling allows, Intuition Wellness may direct you to your local Urgent Care or provide you with the name and contact information of a colleague to contact if necessary.

### PROFESSIONAL RECORDS (initial)

The laws and standards of the profession require that Intuition Wellness Center, PLLC keep treatment records. You are entitled to receive a copy of your records. Because these are professional records, they can be misinterpreted by untrained readers. Your naturopathic physician can explain the contents

and answer any questions. Requests for records must first be provided in writing. Records will be provided within a 30-day period from the time that the written request was submitted. Records can be provided electronically at no charge or in hardcopy format for a fee of ten dollars.

## **MINORS** \_\_\_\_\_(initial)

Parents/guardians are responsible for their children, including when left unattended. If you are a patient under eighteen years of age, please be aware that the law may provide your guardian/parent(s) the right to examine or receive a copy of your records. You should discuss with your naturopathic physician so as to determine together how to best handle such disclosures. A signed waiver is required that authorizes your doctor to treat a minor patient (i.e. adolescent) without a parent/guardian present in the examining room.

## **CONFIDENTIALITY** \_\_\_\_\_(initial)

The privacy of communications between a patient and a provider is protected by law. Generally, Intuition Wellness Center, PLLC can only release information about services to others with the patient's written permission. But there are a few exceptions:

- In most legal proceedings, patients have the right to prevent Intuition Wellness Center, PLLC from providing information about their treatment. In some proceedings a judge may order a provider's testimony if it is determined that the issues demand it.
- There are some situations in which team members at Intuition Wellness Center, PLLC may be legally obligated to reveal patient information to protect others from harm. For example, if a team member believes that a child, elderly person, or disabled person is being abused or neglected, he or she must file a report with the appropriate state agency.
- If a patient is threatening serious bodily harm to themselves or another, the law requires

- protective actions, which may include seeking hospitalization, contacting family members or others who can provide protection, or notifying the potential victim.
- Naturopathic physicians at Intuition Wellness Center, PLLC may seek professional consultation to improve quality of care. Our team meets regularly to staff cases to ensure the highest quality of services. All team members receive regular consultation or supervision and they may find it helpful to discuss particular details. If an Intuition Wellness team member is in training, they will notify you and provide you with their supervisor's contact information. If you have concerns about disclosures, you are encouraged to discuss these with your naturopathic physician.
